After Susan's husband was diagnosed with P.D., they created Move.Laugh.Connect. a comprehensive program used by the Cooper Clinic and DAPS throughout the Dallas area.

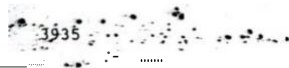
